RECOMMENDATION TO PC

After deliberation and clarifications, the Evaluation Committee recommend, Triple FFF Investment Cc the third lowest bidder for the provision of Refuse Removal at Onhimbu East for 36 Months at an amount of **N\$31 000.00 per month (VAT) inclusive**

DI Pices Investment Cc is the First lowest bidders with amount N\$28 785.00 per month (VAT) inclusive but already recommended at Outapi Central bidding with one vehicle (registration Number N 10737 UP

Mbandanondjala Investment CC is Second lowest bidder with the Amount N\$30 116.00 per month (VAT) incl but is already recommended to Outapi West and bidding with one vehicle registration No (N7586 UP).
